**CONDITIONS OF LICENCE**

1. No person shall purchase or otherwise obtain reject eggs
  - a) for resale
  - b) in an amount exceeding 15 dozen eggs in any one calendar month without a licence from the Minister.
2. An application for a Licence to Purchase Reject Eggs shall be accompanied by the fee provided in the schedule.
3. A Licence to Purchase Reject Eggs
  - a) is not transferable
  - b) remains in force until the 31<sup>st</sup> day of December next following the date of issue, unless sooner cancelled, suspended, or surrendered.
4. The holder of a Licence to Purchase Reject Eggs shall furnish, on or before the 15<sup>th</sup> day of each month, a statement to the inspector showing:
  - a) the quantity of reject eggs purchased or otherwise obtained during the previous calendar month
  - b) the names and addresses of the persons from whom the rejects were purchased or otherwise obtained, and the dates of purchasing or otherwise obtaining the reject eggs
  - c) the purpose for which the reject eggs were purchased or otherwise obtained
5. No person shall purchase or sell or offer for sale reject eggs for use as food, or in the preparation of food, for human consumption.
